Name of the operation :

Microdiscectomy at L5/S1 from left side and removal of huge extruded disc.

Procedure & Findings of Operation:

After satisfactory G/A, patient was placed in a prone position on Hall's frame. Pressure point padded. Operative area was cleaned, painted and draped in usual manner. Disc space identified by C-Arm. A midline 2 cm skin incision was given. Paravertebral muscles separated on left side. Aesculap retractor system fixed. Ligamentum flavum was very thick causing compression to thecal sac from posterior. Very thick ligamentum flavum were removed. Operating microscope was brought in. Under hug magnification further dissection was carried out. Disc space was entered and dessicated disc materials were taken out in piecemeal. Then an extruded fragment was mobilized and huge chunk of disc materials was removed. Then the thecal sac along with nerve root became free. Meticulous saline wash then gentamycin wash was given. Depomedrol was sprinkled over the nerve root. Wound was the closed in layers. Blood loss scanty, No transfusion was given, patient tolerated the procedure well and was sent to post operative ward in good condition.

- * Diet: Normal
- * Tab. Neofloxin (750mg)

* Tab. Napa Extend (665mg)

1+1+1 (after meal) for 5 days
